

BBB shredded more than 24 tons of documents unloaded from over one thousand vehicles on Saturday, October 24th at its 13th Annual Shred Day.


The free event is part of a national effort to reduce identity theft and was held at the Maryland State Fairgrounds. It is also BBB Greater Maryland Foundation's primary fundraiser. Nearly 49,000 pounds of paper were destroyed and recycled, and donations of almost \$2,000 were collected to benefit the 501(c) 3 charity.
