

Community Education

To further our mission of supporting your BBB's vision of an ethical marketplace, your BBB Foundation seeks to educate businesses, charities and consumers to make wise buying and giving decisions.

Your BBB Foundation believes that empowering individuals to make informed decisions helps combat fraud and unethical behavior, championing BBB's mission to be the leader in advancing marketplace trust.

We reach out to our local community in a number of ways:

Presentations/Military Line/Tradeshows & Expos/Publications and Secure Your ID Days

Last year your BBB Foundation was the featured speaker at 12 presentations and spoke to 323 people across northwest Florida before everything shut down in March. We spoke to 4 groups of military members equaling 95 men and women educating them about Military Line resources, scams targeting them and identity theft.

The Lighthouse was printed quarterly (approximately 8,000 copies) last year and distributed. We continued to send out weekly **Tuesday Tips** and **Industry Reports** were sent out twice a month.

Your BBB participated in 2 expos/tradeshows, reaching 221 people before the shut down.

Due to the pandemic, your BBB was not able to hold our annual Shred Events in Pensacola and Mary Esther and saw a reduction in other in-person events.

Student Ethics Scholarship

The Board of Directors decided to carry over the candidates for the Torch Award to 2021 but felt that The Student Ethics Scholarships should be awarded. Award criteria include leadership, community service, academic achievement and an essay about character building. Related Party Transactions

Certain members of the Board of Directors of The Better Business Bureau of Northwest Florida, Inc., (the BBB) also manage the activities of the Better Business Bureau Foundation (the Foundation). The BBB funds a significant portion of the Foundation's expenses, as the Foundation is not up to full fundraising capacity. The estimated value of staff assistance, office space and shared expenses paid on behalf of the Foundation by the BBB are shown as in-kind contributions in the statement of activities. The amount of in-kind contributions received from BBB totaled \$58,342 for the year ended December 31, 2020. In addition, BBB contributed cash to the Foundation in the amount of \$12,258 during the year ended December 31, 2020.
