USE OF THE ENTRY

I understand that the entry created for the purpose of participating in the BBB High School Multimedia Contest and submitted to the BBB will become the intellectual property of BBB Midwest Plains ("BBB"). I acknowledge and agree that BBB will own all rights, title, and interest, including, but not limited to, all copyrights and other intellectual property rights, in and to the contest submissions. I understand that once this form has been submitted, BBB will have the right to use these materials for any purpose, commercial or otherwise, including, but not limited to the use in advertising and marketing efforts, illustration, and web content without attribution or compensation.

LIMITATIONS OF LIABILITY/RESERVED RIGHTS

BBB shall not have any obligation or responsibility with regard to (i) submissions that contain incorrect or inaccurate information or do not comply with these rules, (ii) submissions, prize claims or notifications that are lost, late, incomplete, illegible, unintelligible, damaged, or otherwise not received by the intended recipient, in whole or in part, due to computer or technical error of any kind, or (iii) telephone, electronic, hardware, software, network, Internet or computer malfunctions, failures or difficulties, or (iv) any damages or losses of any kind caused by any prize or resulting from participation in the contest or acceptance, possession, or use of any prize. BBB, in its sole discretion, reserves the right to disqualify any person tampering with the submission process or the operation of this website or otherwise violating these rules or any applicable law. BBB further reserves the right to cancel, terminate or modify the contest if the contest cannot be completed as planned because of unauthorized intervention or technical failures of any sort.

COMPLIANCE WITH COPPA

BBB abides by federal COPPA ("Children's Online Privacy Protection Act") regulations. COPPA requires operators of websites and online services such as mobile apps, network-connected games, online purchasing, VOIP services, Internet-enabled gaming platforms, and location services to provide notice and obtain parent's consent before collecting personal information from children under the age of 13. In order to use the BBB High School Multimedia Contest website to participate in BBB's High School Multimedia Contest, certain personal identifying information, generally the student's name and email address, must be provided to BBB and the website administrator. BBB may also collect data that is not personally identifiable to track website effectiveness, traffic, and other analytics. To comply with federal law, this form shall constitute formal parental notification and formal parental consent for your child to provide personal identifying information to BBB and its vendors for the purpose of facilitating participation in the BBB High School Multimedia Contest.

PRIVACY POLICY

I hereby waive the right to receive any payment for signing this release and waive the right to receive any payment for BBB's use of any photographs and videos authorized by this release.

TERMS AND CONDITIONS

These Terms and Conditions shall be governed by, construed and interpreted in accordance with the laws of lowa, Kansas, Missouri, Nebraska or South Dakota, depending upon the state in which the entrant resides, without regard to their conflicts of law provisions. No material deemed vulgar or pornographic by the judges will be considered. This will include material that is criminal, copied, harmful to children, contains private information of a third party, is discriminatory in nature, or features any activities that reflect unfavorably on, or otherwise adversely affect the public image of BBB or the BBB High School Multimedia Contest. Appeals for reconsideration can be made, in writing, to the BBB. However, the final determination will be made solely by the BBB. An award will be given to the first-place entry. Winners will be notified by email before the end of the school year.
